Whither Are We Going?



"Whither am I going?" was the question raised in the mid-18th century by Francis Asbury, an American clergyman. This question was raised in the context of a search of a new world for the proclamation of the Kingdom of God. The purpose of Asbury's journey was "not to gain honour or earn money but to live to God and to bring others to do so."

Today, we are invited to question ourselves, "Whether am I going?" "Whether are we going as a Province?" The Universal Apostolic Preferences 2019-2029 were promulgated on 19th February, 2019. We completed the draft of Province Apostolic Planning (PAP) in November 2020 and started the process of interiorization in the First Week of Advent in December 2020. We were instructed by the UAP-PAP Core Committee to complete the entire process of interiorization in 8 weeks. The first quarter of February 2021 is gone and more than 50 per cent of our communities haven't completed the process. Some communities have not even started. Whither are we going? Where is our priority and commitment?

Soon we will begin the Lenten Season, a time of reflection, self-examination, personal and communal transformation. Lenten Season 2021 is an opportunity and an invitation for us to reflect individually and collectively on the interiorization, ownership and productive implementation of all action plans proposed in the Province Apostolic Planning.

I wish you all a blessed and fruitful Lenten Season 2021 and invite you to own up the UAPs and PAPs and "resolve to concentrate and concretize our vital apostolic energies" during the next ten years.

eevandhara School has been running offline classes despite the COVID-19 lockdown in the country since October 2020. The suggested online classes as well as *para* classes were not feasible at all here. Parents were getting impatient to send their children to schools and on the other hand, students were eager to come to the



school. The school management decided to take a middle path of conducting classes in the school campus but; classes are held under trees with required physical distance. Once classes are on, the sight of the campus gives a feeling of an ancient ashram school. About 80% of students turn up for classes every day. The school has thus given students some learning opportunities with this approach during the lockdown. Even the prescribed assignments for students are written down like examinations. Students are given questions beforehand for preparation and they have to write assignments like any other examination in the school campus. This approach motivates them to study rather than just copying the answer from books.

The school upgraded and added some basic infrastructural facilities for students. Long-awaited separate toilets for boys and girls were inaugurated on January 11, 2021, by Shri Kheersagar Sawra, Sarpanch, Karpi Panchayat, an alumnus of the school, in the



presence of students and a few parents. It was blessed by Fr. Ajay Kumar Kujur, S.J., Superior, Mauhapali-Barmakela Community. In the absence of these facilities, boys went to the forest for their natural calls, and girls managed with a single toilet in the campus. Along with the above inaugurations, the school also inaugurated drinking water stand for students. Now all students take water from the water stand. All these small projects were made possible due to the hard work of Fr. Blacius Kerketta, S.J., Fr. Eligius Kandulna, S.J., Fr. Sandeep Tigga, S.J, Fr. William Beck, S.J. and Fr. Alfred Toppo, S.J. The school also is grateful to all well-wishers and donors for actualizing these projects for students.


Fr. Yacub blessed two marriages of his nephews and on 29th offered thanks giving Mass on the hilltop of Gundhara with his villagers.

St. Xavier's, Ambikapur

The community members organized a protest at Gharee Chowk against the arrest of Fr. Stan Swami in the second week of October 2020. The members of the IPTA (Indian People's Theatre Association - a pre Independence 1943 Association, promoted themes related to the Indian freedom struggle. Its goal was to bring cultural awakening among the people of India. Post-independence, IPTA, works for Equality of the citizens and brings together theatre artists from across India to illustrate political and social issues through dramas, street plays, and theatres) participated in the protest.

The IPTA members organized the protest against the arrest of Fr. Stan Swami. The CRI members of Ambikapur also participated in the protest. Then a third time, the Jesuits called for yet another protest, "Solidarity - stand for Fr. Stan" against the arrest of Fr. Stan Swami. A large number of people of goodwill of the town and a big number of CRI members came out to stand with Fr. Stan. Hence, the protest show was at Gandhi Chowk and the Gharee Chowk since the number of participants was large and hence it was imperative to observe Covid – 19 norms of the Government. The speakers spoke on different topic like - the first speaker at Gandhi Chowk questioned the manner of arrest of Fr. Stan, where NIA, despite interrogating for several hours earlier, issued a summon to Fr. Stan to travel to Mumbai who is 84 years old, and later arrested from his residence in Ranchi, Jharkhand. The second speaker said about the draconian law: "Unlawful Activity (Prevention) Act, 1967", (UAPA) or anti-terror law, as amended by the Lok Sabha in 2019; and its irrelevancy in today's time in a democratic country like India. The third speaker told the participants about the provisions of the Indian Constitutional Fundament Rights and esp. the Right to Freedom (Art. 19) and the Right against Exploitation (Articles 23 & 24) and that the present Government is violating the Fundamental Rights of the citizens indiscriminately. Then, all the participants marched to the Aakashvani Chowk at the Statue Mother Teresa, of Where there was a prayer meeting for half an hour with lighted candles. The Community members also took part in the Protest, organized by IPTA against the three Agricultural Laws of the Central Government at the Gharee Chowk.

The Community participated in the second protest organized by the members of IPTA, in fact, not a protest, but to show solidarity with the farmers and to give homage to the farmers, who died during the protest in Delhi. Then, there was yet a third protest, organized by IPTA, the community took part against the three agricultural laws of the Central Government. In the protest, the copies of the three laws were burnt all over India.

Fr. Nirdosh Ekka, went to the village Saphaulee, in Lundra Block, in the district of Surguja, Chhattisgarh, with the members of IPTA to conscientize the farmers on the three Agricultural laws, namely : (1) The Farmer's Produce Trade and Commerce (Promotion and Felicitation) Act, 2020, (2) Farmer's (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020, (3) Essential Commodities (Amendment) Act, 2020 of the Central Government on 05 – Jan – 2021. We meet the small farmers in small groups 3 to 5 at a time. We are contacting the farmers to their village by village. We explain the consequences of the 3 agricultural Laws. The three laws appear in their principle very rewarding, nice, and beneficial to the farmers. Inherently, they benefit the Capitalists, the corporate, and the powerful. The 3 agricultural laws are, in fact, sugar-coated poison. The small farmers will be the most losers. They will end up becoming daily labourers in their plot of lands. The door of the Judiciary is closed to the farmers. "Will the bureaucrats be just in their administration justice?" - is a big, worth centillion question.



On 26 – Jan – 2021, the members of IPTA and Fr. Nirdosh visited another village, called Karakee, in Lundra block, in the district of Surguja, in Chhattisgarh. We participated in the flag hoisting of the village, where the

sarpanch of the village unfurled the National flag. The IPTA honoured the sarpanch for his honest work.

On the Martyr's day or the Peace Day, 30 - Jan - 2021, the community members along with CRI members and the people of the town gathered at Gandhi Chowk, Ambikapur to pray for the welfare of the Nation and the leaders of the country and the citizens, and to pay homage to the Father of the Nation. The four priests, from four religions, i.e., Hindu, Islam, Sikh, and Christian, said the prayer one by one. Fr. Nirdosh led the prayer by requesting the congregation to repeat the prayer after him. Then, the congregation lighted the candles and observed two minutes silence, and ended the 'Sarvadharma Prayer meeting'.

Mr. Potai assured all to raise the issues of the tribals specially the issues of Land



(Patta) and caste certificate of the Kodakus at the state level. There was a big rally from Balrampur to Chando. Kodakus performed a sondo dance. All appreciated the dance. It is the sign to keep the Adivasi culture alive and safe.

A short meeting was held for the Dhanwar Alumni on the 17th January. Fr. Palacidus Kujur, In-charge of Alumni and Fr Bipin Kujur guided all the members present in the meeting and encouraged and called them to strengthen the group. It was well appreciated that former students of Dhanwar started coming up and taking the initiative to help the mission.



There was a meeting for Kodakus in Champapur on the 22nd of January. Kodakus had gathered together, more than 400 of them in number from different villages. Mr. Basant Kujur, President of Sarva Adivasi Samaj was the main speaker who told them about their rights and duties in the community. He also assured to help them to get the land records (Patta) and caste certificate. Mr. Francis Maes was also present in the meeting and he asked the Kodakus to send their children to Dhanwar for better education and life. On 22nd January Akashwani group from Ambikapur came to Dhanwar for the interview with the farmers. They asked the Kodaku farmers how they cultivated the crops and other grains. It would be broadcast on the radio program Kisan Badi every Wednesday 7.30 at PM in Akashwani, Ambikapur. On 26th January, the Republic day was celebrated in St. John Berchmans School Dhanwarkala. The program was very short because of covid-19. There were two Sarpanches from Bada and Dhanwar as Chief Guests. The program was short and meaningful.

JESUIT MISSION IN MP : ARTICLE 36

On 28th February1912, the Archbishop wrote to Sir A. Napier: "I am just back from a tour in Chota Nagpur. There is no news so far of the coming to Jashpur of the Political Agent. You told me that you were going there in March. I write to ask you to take up the Kastura case, if Mr. Blakesley has not done so in the meantime. As Fr. Van den Driessche who has been blamed by the Raja for this affair and consequently has a right to be heard in self-defence has to do a great deal of touring in the large district under his care, will you kindly give him timely information of the date at which he will be required at Kastura or in Jashpurnagar? From the conversations I lately had with the Missionaries who work in Jashpur, my former impression that the Raja is trying his best to coerce his people into abandoning Christianity, has been confirmed and strengthened. I trust you will not allow this injustice to go on under the protection of the British Government."

Sir A. Napier replied immediately on 3rd March 1912, mentioning that His Grace's letter has been forwarded to Mr. Blakesley. Finally on 29 March, Fr. Van den Driessche was able to inform His Grace that the interview with Mr. Blakesley had taken place, not at Kastura but Charaidand: "I hope that with God's help I have said nothing too much or too little. The affair of Kastura evidently came up too. I have exposed what happened there. The Political Agent gave me a copy of the Raja's accusation against me. Here it is, from a letter of the Raja to the Political Agent, dated 2nd July: Raja's accusation. 'It is reported that at the time when the Holy Car festival of Jagannath was being held at Kastura, where it is annually held, one Rev. Van den Driessche turned up with some catechists and tried to gather round himself the people who were otherwise engaged in works connected with this festival; but this failing, he came again the next day (29th June) with a large number of catechists and went near the temple calling for the men who were at work that day also and while so doing abused and intimidated a lower grade state official, who went to see that those men were doing the works allotted to them. I am unable to regard this alleged conduct on the part of the Rev. gentleman hardly in keeping with the noble profession he professes; much less he was justified in so doing whatever his intention might be.' In a 2nd letter, 24th July: 'With regard to what happened at Kastura, I (Raja) would among others, only point out to two things now, first, the missionary gentleman rode up to the temple which he ought not to have done out of consideration for our religious susceptibilities at least, secondly, he prevented the Christian raiyats of Kastura and Pakertoli from going to work in connection with the Jagannath festival, but I think that it is no part of his evangelical works. Of others, I shall say when necessary."

"When the Political Agent had read these two extracts, I (Fr. Van den Driessche) have absolutely denied the accusation and I have asked for a copy to be able to answer in detail. I may say that every sentence of the accusation is false and a lie! And I shall try to show this clearly in my answer. As I have said, the Political Agent limited his action to write the "statement" which I have made (that lasted nearly 5 hours) without making any observations, satisfying himself with occasionally a question. What will come out of it? Good, I hope, unless all these papers remain in the drawers!"

Note that the accusation made has now been shifted from the people creating a disturbance to the Father. In the next letter to His Grace, 19th May 1912, the Father writes: "The Political Agent has acknowledged with thanks the receipt of my letter of 14th April with its enclosure: my answer to the accusations of the Raja. He adds: 'I have read the letter and will duly consider it in connection with the Kastura case.' Hence we may hope that the Kastura case will not be shelved in Raipur, as it was in Nagar. Besides in my answer, I asked in conclusion that the accusations be withdrawn or, if my answer was not considered as convincing, that an enquiry should take place where I might be brought face to face with my accusers, adding that I insisted because I was accused by the Raja not as a private person, but, as appears from both letters of the Raja, as a missionary." After 8 months waiting for the final result of that enquiry, the Father sent a reminder to the Poltical Agent, dated 11th December 1912. It took another 4 months to get the long expected decision. This the Father communicated to the Archbishop on 23rd April 1913 more than a year after the interview itself. Here is what the Political Agent said:

1. "With reference to the first part of your letter of 11th December enquiring whether any decision has been arrived at concerning the alleged beating of some Christians at Kastura on 24th June 1911, and specially with regard to complaints made against yourself by the Raja Bahadur of Jashpur in his letters dated 2nd and 24th July 1911, I have the honour to inform you that the alleged beating of Christians forms the subject of part of a report which I am submitting to the Local Administration whose orders about it I will communicate to you in due course when received.

2. "With regard to the complaint of the Feudatory Chief against yourself, to which you refer, I have the honour to inform you that I (Political Agent) wrote to the Feudatory Chief informing him that I had received from you a written assurance that you never went to Kastura at all on 28th June, being all the day at Pakertoli, a mile distant, that you went from Pakertoli to Saraitoli on 29th June by the usual road which passes through Kastura, with only two catechists, and that you did not go nearer the temple than the ordinary thoroughfare, nor did you stop in its neighbourhood, that you did not call any one from work, nor abuse nor intimidate anyone there; and that you are not conscious of having done anything to wound the religious susceptibilities of anyone. The Feudatory Chief has written to me in reply stating that he accepts your assurance as he understands that you are a minister of the Christian religion and he, therefore, does not wish to press the case any further."

3. "With regard to the statements contained in the rest of your letter under reply, I regret that I do not see my way, on the information before me, to taking any action in the matter. It is open to any subject of Jashpur, Christian or otherwise, who has a grievance, to have recourse to the ordinary state courts. I do not agree with your view that it is useless for them to appeal to the constituted state authorities. On the contrary, the results of my extensive

enquiries made last year have led me to the conclusion that the Feudatory Chief and his Magistrates have done their best to administer even justice between Jashpur subjects of various religious professions in the past, and I have no doubt that they will continue to do so in the future." The Father's comment: "A certificate of impartiality granted to the Raja that deserves to be framed! One might ask what would have happened if the Feudatory Chief and his magistrates had not done their best etc., perhaps they might have been sent to jail for a few months. The Kastura Christians and the two Christians Birsai of Tapkara and Phalsa of Kelba, who having had their fields confiscated, complained in court! Our idea of justice must be quite different from theirs!"

"For no. 2, does it not look as if I (Fr. Van den Driessche) had apologized to the Raja who had accused me and who now is kind enough to "accept my assurance"? The Political Agent seems to have forgotten to tell the Raja that besides my "written assurance" I gave him two proofs to show clearly that every word of the Raja's accusation against me was untrue; perhaps the Raja knew as much without requiring these proofs, and this is why he "does not wish to press the case any further! Finally, with regard to no. 1 (Kastura case) I expect we shall have to wait a long time before we hear again about it!"

bent on turning Kastura region again pagan. Success there would have meant success elsewhere. The boldness of Fr. Van den Driessche was contagious for his people and from cowards made them bold also, ready to endure anything to preserve their Faith. This contagion spread all over the Nich Ghat and put all the Christians on their guard under the ever vigilant eyes of their pastor. In more than one letter he considers this severe persecution like a crucible from which the Christians emerge purer and better than they were before, more steady in their religion, more tenaciously clinging to it. On Kastura side some vacillated for a time, but today all the Uraons of the said villages are Catholic.

On 8th October 1911, when welcoming His Grace, on his return from Europe, Fr. Van den Driessche said: "You will know already how steady our Jashpurrians have kept on this side up till now. Humanly speaking we could not have expected it, and it has been evidently the work of our Lord who wants the Uraons of Jashpur to remain his own. I cannot thank him enough for the very special help He has given us in the midst of our difficulties, and the best manner to show Him my gratitude will be, I think, to keep up the courage of the people until they can get some relief." We may not close this chapter without paying a tribute to the very clever manner in which Fr. Van den Driessche conducted this case, in particular the enquiry at Kastura, and the proceedings during his stay at Nagar. It is worthy of a truly clever lawyer.
