
The Nation Stands with Fr. Stan Swamy and other Human Right Defenders

Article 46 of the Constitution of India states that "The State shall promote with special care the educational and economic interests of the weaker sections of the people and in particular, the Scheduled Castes and the Scheduled Tribes, and shall protect them from social injustice and all forms of exploitation."



But this basic Constitutional right seems to be written off. Today, the Constitutional rights and provisions for the protection of the interests of the Schedule Tribes, Scheduled Castes and other deprived sections of India have been ignored or very conveniently forgotten. Those who have been voicing for the rights of these deprived communities have been silenced or put behind bar.

Fr. Stan Swamy, S.J., who was unjustly arrested on 8th October, is one of those who are forced to be behind bar because they stood for the rights of the Adivasis and Dalits. He is allegedly found criminal and is labelled as a supporter of the naxalites because he empowered the Adivasis and protected their rights. He took a strong stand with them on issues related to the violation of laws in acquiring land for mega projects for mining and infrastructural development which flout the rights of the Adivasis. He has consistently raised voice in democratic and legitimate ways against the unrestricted exploitation of land and natural resources. He opposed the indiscriminate arrests of thousands of young Adivasis under the label of 'naxals' just because they resisted the unjust land alienation and displacement. He has questioned the non-implementation of Panchayats (Extension to Schedule Areas) Act (PESA), Samatha Judgement 1997 of the Supreme Court and Forest Rights Act 2006. He has expressed apprehension at the amendment to the 'Land Acquisition Act 2013' and the setting up of the 'Land Bank' by the Jharkand Government which will empower the State Government and the land mafias to acquire Tribal ancestral, community and agricultural land.



Just before being arrested Fr. Stan Swamy wrote, "Over the last two decades, I have identified myself with the Adivasi people and their struggle for a life of dignity and self-respect...In this process, I have clearly expressed my dissent over several policies and laws enacted by the government in the light of the Indian Constitution. I have questioned the validity, legality and justness of several steps taken by the government and the ruling class. If this makes me a 'deshdrohi', then so be it."

What Fr. Stan Swamy has said and done is perfectly constitutional because "the right to dissent is one of the most important rights guaranteed by the Constitution of India. As long as a person does not break the law or encourage strife, he has a right to differ from every other citizen and those in power and propagate what he believes is his belief."

Hence, we condemn the arrest of Fr. Stan Swamy, stand with him and pray for him and for all the human rights defenders and all those who are wrongly imprisoned and harassed for standing up for the truth and justice.

Priestly Ordination

The long awaited dream of ordination of Deacon Suresh Tirkey and Deacon Anmol Lakra was ultimately accomplished in Loyola, Kunkuri. The parishioners of Kuturwan and Bhelwa were longing to see the ordination of Deacons Suresh Tirkey and Anmol Lakra in their respective parishes. The ordinandis had set the dates in the month of May and the authorities had agreed but the pandemic intervention differed the time and space. But Covid-19 could neither stop nor cancel the blessing of ordinations. God ordained His chosen



ones on 10 October by His Lordship Rev. Emmanuel Kerketta, D.D. in the presence of Fr. Ranjit Tigga, Provincial, Religious, Priests and the congregation of about 100 family members, friends and well-wishers. The celebration of ordination was solemn with simplicity. Altar boys, Deacons, Priests, Religious and Bishop escorted the ordinandis with their parents in two lines without an entrance dance. The choir, composed with Scholastics ushered them in the chapel of Loyola hostel with their beautiful melody. All other dances also were suspended.

The Holy Eucharist started as usual and continued until the handing over of the ordinandis by theirs parents. But this time "Kala Kala Beta" (go mai son) was dropped. The ordinandis were not handed over by their parents but they themselves walked up to the altar and surrendered themselves to His Lordship to be anointed and ordained. The ceremony of ordination was as usual. But the Bishop observed the protocol of Covid-19. Neither did he kiss the palm of the ordinandis nor embraced them after anointing and ordaining them. So did the priests who



neither lay their hands on the head of the ordinandis while praying for the blessing of the Holy Spirit nor kissed the hands nor embraced them after the ceremony of ordination. They prayed from their respective places. The participants had occupied their chairs in a distance

as per the norms of Covid-19. There was a perfect discipline during the entire ceremony.

The family members and well-wishers were very happy. They wished the ordinandis and took photos with them after the departure of priests and the Bishop. All were happy interiorly. There was no external expression by dancing. All were provided with delicious meal by the Loyola House in its open quadrangle.

St. Xavier's Rajpur

The on line class for the students is quite encouraging; moreover some students are still getting left behind due to various reasons. On 5th of October Fr. Polycarp Xalxo SJ, superior of Jhingo-Rajpur community went to Ash Deep Pathalgaon for the orientation programme for Rectors, and Superiors on community level Action plan (UAP-PAP) which held on 6/10/2020 at Asha Deep Pathalgaon. It was one day programme, so he came back to community very next day. Immediately after coming back from the meeting, he already started planning out for the community recollection to prepare the action plans. We had a full day recollection and decrement the action plans were

made for the community level on 19th of October. Prior to this on 02/10/2020, Fr. Sebastian Tigga SJ had gone to Balrampur to attend the Private school's Principles and teachers meeting which was convened with the purpose of constituting Private school teachers' association in the wake of government's announcement that students from private school could take admission in the government school without the transfer certificate and mark sheet. The effect of it was that many students left the school and took admission in the government schools without clearing the dues, which created heavy financial burden to the schools.

For the future course of action, again, on 12th of October the principals and teachers of Private school had a meeting at St. Xavier's school Rajpur. The purpose of the meeting was to formulate Bylaws for the private



schools teachers association of Balrampur district. Good number of teachers and principals of private schools working in Balrampur District were present in the meeting.

On 24th of this month there was another important meeting held at St. Xavier's School Rajpur of principals, head masters and managers of the Christian minority school working in Balrampur. The agenda of the meeting was, government promulgating 'the private School fee regulation law'. It is felt that the government's move is the clear violation of Article 30 of the constitution which protects the minority schools. According to this Article, minorities institution have a right to establish and administer their schools. It was unanimously agreed upon that we have to write a memorandum to government officials to exempt the minority schools from this Act. For the same purpose, a committee was made which will submit the memorandum to government.

St. Xavier's, Ambikapur

n the month of October St. Xavier's Residence Ambikapur was fully engrossed in UAP-PAP programme and formulating its Community Apostolic Preferences (CAP). The community had a full day recollection on 17 Oct. beginning with mass and ending the day with Supper. The day was spent on presentation of Internal and External Context, presentation of Province Vision Mission and Province Preference, prayerful reading of PAP identifying the ones applicable to the community, SWOT analysis, sharing of Consolation and Desolations and reflection on PAP that community might implement. Thus, community was properly oriented to enter into the CAP. After having read the PAP document and serious reflection from 21st to 24th Oct community sat together from 6.00 pm to 8.00 pm everyday and finalized the CAP draft.

The heart-breaking news about the arrest of the social activist, Fr. Stan Swami aged 83 year old on Thursday, Oct. 8, 2020 by NIA was a serious blow on all the Human Rights and Social Activists of the country. Following the arrest, on 12 Oct. at 4.00 p.m., a common adoration was

organized at Bishop's house Ambikapur and a group of people went to *Ghadi Chawk* for a small demonstration and a memorandum was handed over to the Upper Collector by the members of CRI, AICUF and some lay association to be forwarded to the President, Prime Minister, the Home Minister of India and to the Governor of Chhattisgadh. On 13 Oct for the same cause, there was another protest by Indian People Theater Association (IPTA), JALESH, Kishan Sabha, Tritya Varg Karmchari, Bhagat Sinh Akadami, St. Xavier's Accademy, Holy Cross and ASHA association. There was a mega *Sadbhavna Sabha Pradershan* with the initiative of St.



Xavier's Community Ambikapur on 16 October on Ghadi Chawk and Ghadhi Chawk Ambikapur. After speeches and meaningful slogans for the release of Stan Swamy and other Social and Human Right activists, a peaceful silent procession proceeded towards the Mother Teresa memorial near Akash Vani Chawk. There also a speech was delivered by Mr. Jitendra Singh Sodhi and a simple prayer service was conducted by Ursuline sisters and thus the rally was concluded. Around 150 religious priests and nuns, lay people and others participated in Sadbhavna Sabha Pradershan observing the Covid-19 protocol.

On 1 Nov. in the old Loyola Hostel campus, the office of *CG Catholic Uraon Samaj Surguja* unit was blessed and inaugurated in a simple ceremony by Rt. Rev. Bishop Patras Minj, S.J. This office is established to conduct some motivational and prefessional programmes for catholic youth in view of strengthening the unity among catholic tribals.

Cocial Awareness given in "Tusgo" Celebrations On → 11th October, 2020 "Tusgo" (Nawa Khani=eating of new grain) was celebrated at Saraitoli, Kastura. After many days people gathered in the village Church to celebrate the feast. It was a kind of faith renewal too. The faithful entered the Church in procession with singing and dancing to give thanks to God for the new crop. The Church failed to contain the faithful. The Mass was celebrated in Kurukh. Yacub Kujur, in his homily and message highlighted the issues of values of tribal life. He told that to be called tribal, a community has to fulfil five conditions. 1) Specific geographical boundary- it is being provided by FRA, so every village has to get Community Forest Rights. The present State Government has promised to give in its election manifesto. So without delay it has to be obtained through Gram Sabha.

Specific and distinct language, so Kurukh language has to be promoted.

3) Specific and distinct culture, so customs, traditions, singing-dancing, arts and artefacts, traditional knowledge need to be preserved and promoted.

No caste discrimination: there is no caste discrimination found in the Uraon community.

5) Compared to other communities be in aboriginal stage/state-in comparison with other communities the Uroan community is in an aboriginal state. He invited the listeners to evaluate one on the above points and improve if they were deviated. Arrest of human rights activists, intellectuals and journalists in fabricated case by NIA in connection with Koregaon incident was explained to the listeners. Adv. Sudha Bhardwaj from CG and other 14 such persons were arrested and imprisoned. They were a voice to the voiceless tribals

who are being displaced for mining and other developmental projects. Recently, Fr. Stan Swamy, SJ has been arrested by a team of NIA at Ranchi and is imprisoned. For he raised voice against tribals being illegally displaced for mining and other developmental purposes, spoke in favour of under-trial prisons which challenge the system so is accused as urban naxal as other 15 persons put behind the bars.

Yacub also advised the listeners to benefit from government schemes and make better their life by removing poverty.

In the evening there was traditional Karam celebration by the villages. Yacub told the Karam story emphasizing on protection of ecology and environment. The villagers danced around the Karam branches whole night.

12th October was observed as solidarity day to stand by the accused and arrested by the NIA and to oppose the move by condemning the act. It was organized under the banner of ST, SC, OBC Manch, Pathalgaon at Indira Chowk, Kerakchhar (Bulcan) Chowk and Pakargaon Chowk. The SDM permitted to hold the program in following the rule of Corona. The participants at Indira Chowk stood all around holding banners and placards written following demands-i) release the human rights activists such as Sudha Bhardwaj, Fr. Stan Swamy and other 14 persons, ii) give justice to human rights activists, iii) stop harassment of journalists, iv) take back the Acts passed against farmers, v) respect girls and girl children, vi) "Beti Padhao, Beti Badhao Nahin Pahle Bachao", vii) punish the rapists, viii) stop privatization and communalization, ix) "Hanthi Bhagao, Aadmi Bachao", x) "Jati Praman part men dhandhali band karo" xi) stop unsustainable use of natural resources, xii) declare minimum support price to all agri-produce. All these demands were included to give wider perspective to the day. Thanks to the persons who came out to support the issue and to the local administration to granting permission and the media for giving wide

13th October was the day of "Tusgo" to the people of Jamjunwani. Fr Gyan Prakash Kujur was the main celebrant and Yacub the con-celebrant. Fr. Gyan stressed on being strong in faith, giving tenth, loving the neighbour and observing the directives of COVID-19 in his homily. Fr. Yacub gave his message as on 11th October above and Marcus Ekka and Ashikala Ekka (animators) encourage people to take benefit of government schemes through Lok Manch Programme. After the Mass the boys and girls enjoyed Karam dance.

On 17th October a meeting of youth animators of Jashpur diocese was held at GVK, Kunkuri. About 15 Fathers, one Sister and 4 boys of diocesan "Yuva Sangh" were present. Fr. Mukti Minj, the Regional Youth Director, welcomed the participants and told the purpose of the meeting to plan for youth of today in the COVID-19 situation. Fr. Ranjit Kerketta, the diocesan

youth director led the participants into a prayer. Fr. Kanchan Tirkey, spoke on the role and participation of youth in socio-cultural life. Fr. Satya P. There were about 100 farmers. The officials of the company explained about the nutrients of mushroom, cultivation process, marketing and benefit of chain marketing.

On 25th October JVM arranged a training program on mushroom cultivation and marketing. The program began with recitation of the preamble of the Constitution of India. Fr. Yacub welcomed the trainees, numbering 52 and especially Fr. Robert Tigga, SJ, the Superior of the house, Fr. This extra earning will not only help in satisfying the basic needs but also will help in serving the needy with love and justice leading to obtain heaven. He advised the farmers to adopt at least three occupations for better living.

Mr. Sandeep Ram explained in detail the procedures of mushroom cultivation, sale of the product and benefit of net marketing with the company. He told that the row mushroom can be sold at market and if not the company will buy the dry product and the company is producing many nutritional products out of it. Mr. Mahendra Ram shared his rich experience and earnings with mushroom and net marketing. Thence the trainees had practice of filling the straw and seeds in poly bag.

JESUIT MISSION IN MP Article 33

Recourse to the Diwan

The Diwan informed by the Father of these facts, promised on 30 June an inquiry, but on 1st July requested him to advise them to make a lawsuit. "On Friday, 30 June, I (Fr. Van den Driessche) went to complain to the Diwan in Jahspurnagar. The Diwan received me very kindly on the same day, and I told him what had happened. I answered that the reason was plain from the different testimonies I had gathered, namely, it was because they were Christians and to force them to give up their religion.

The Diwan answered that it was not for that reason, but that according to a report he had received on Thursday, it was because the Christians had made a disturbance on the pagan feast, and one of them was said to have pulled the beard of the bhandari! "Imagaine my surprise and my indignation! It was not enough to have treated my Christians like dogs, they had still to be calumniated! I told the Diwan that this accusation was a lie, and a pure invention, and a very clumsy one too."

"If the Christians have made a disturbance on the feast which was Wednesday 28th, then (1) How is it that they were beaten from Saturday night, 24th? This date was given not only by the Christians, but by an Independent witness Liro chaukidar, a pagan, as I have related above (2) How is it that I did not notice the slightest sign of a disturbance, although I was in Pakertoli near Kastura since Tuesday 4.30 p.m. and could see and did see the procession from a distance on Wednesday afternoon? (3) How is it that after the procession, the children from other villages, who came to me and whom I asked what they had seen, did not mention that there had been trouble? (4)) How is it that not a word was said about any disturbance having taken place, not only by the Christians but not even by Liro chaukidar, or by Matlu and Lumbha, sons of the thikedar of Khutitoli, or by Ram Lakhan, barahil?"

"As I have related above, I saw this Ram Lakhan, barahil, on Thursday morning, in Saraitoli, where he came, I suppose, to see what I was doing; he denied the accusation brought against him, but did not so much as insinuate that Christians had made a disturbance on Wednesday. Why did he not speak

of it? Is it not because the story of the disturbance and the beard-pulling had not yet been invented? And was it not invented just afterwards, and sent at once to the authorities in Jashpurnagar, because the rascals saw that I was getting at the true fact, notwithstanding the threats they had made against my Christians, in case these should have dared to speak to me? (5) How is it finally that I heard about that disturbance only in Jashpurnagar, on Friday afternoon, when I was since Tuesday afternoon on the spot where it was said to have taken place, and had not heard about it then? I wonder how these questions or any of them could be answered, unless it be admitted that it is clear as daylight that this story of a disturbance and beard-pulling is a pure fabrication and a vile calumny?"

"The Diwan finally admitted that it seemed he had been "wrongly informed" and I told him that I was sure that the information he had received was absolutely false. He tried to fall back on something else, namely, that the Christians should not have gone to see this procession (a public one, please) without any permission of the Raja, because the pagans might have resented their presence!!! However strange this theory may be, I did not want to discuss it just then, and stuck to the facts, namely, that the pagans had not resented the presence of the Christian spectators, and that the whole story of the disturbance was a calumny. Finally the Diwan promised me that a full enquiry would be made."

"I left him a succinct statement of the facts as I have related them in this letter. I intend to send him a refutation of the calumny. I shall keep a copy of it." As the Father attaches so much importance to the facts for future vindication, I (Fr. Vermeire) have been careful to give them in extenso just as related by him.

"I am waiting now for the enquiry promised by the Diwan. I expect very little from that side, but at least, if we do not obtain justice for our people from the Jashpurian authorities, we shall have one more well ascertained fact to show the hypocrisy and injustice of those authorities." He adds that he feels pretty confident that Saraitoli, Khutitoli and Pakertoli will remain faithful. I have little hope for Sarbahla, a village which has always been kachcha (raw): nobody has ever been in school from there, nor have any babies been baptized."

At the end he announces the following letter of the Diwan, just received Jashpur 1st July 1911: "From the note you handed me yesterday, some criminal allegations appear. The note is not in the form of a petition. I therefore request you to advise the rayats aggrieved to lodge a formal complaint in the criminal court of the Estate." "During our conversation it appeared that the rayats in question were afraid. But I do not know they were afraid of what, and why they should be so, in face when so many rayats get decisions to their satisfaction. There being no order to maltreat the Christians, I do not find reason why they should not get justice after enquiry. If you want an informal enquiry, I may do it."

"I answered that I would try to persuade the Christians to lodge a formal complaint, although I feared it would be difficult to persuade them on account of the fear they have." He tells Fr. Waelkens that if he does not succeed in making them lodge a complaint, he will himself send in a formal petition to have an enquiry made; with punishment of the guilty and that he would remain there to assist at the enquiry and try and inspire some courage in these poor fellows." They lodged a complaint, but 12

days later, on 14 July 1911, Fr. Van den Driessche informed Fr. Waelkens that the case had been shelved: no justice for these poor Christians! The 5 men of Saraitoli who had been beaten were told to come to court on Wednesday 12th, and bring their witness Liro. But the latter could not be found. "On Wednesday, they were, as far as I understand them, advised to withdraw the case as they had no witness, and so they did (details later). This seems to be the end of it, as far as Jashpur is concerned, but I hope you will not allow matters to rest there. It is useless to try Raipur, because they (the five) have been made to swear that they would not come back with their case. And on the whole, I think, it is better for the cause of Jashpur, that things have been "shelved" in that way in the court. There is, I think, no question for our Christians, qua Christians, of getting justice there. I shall write you all what has happened, and you will come to the same conclusion, which I think is yours already. "I have followed the whole thing closely to be sure of all the facts and I have seen from close-by the rascality of the police, which is either allowed or intended by the authorities.

"The remedy must come from the higher authorities, and I hope we shall find means of getting it. I cannot believe that when the English officials know the state of affairs, they will refuse to interfere. If we keep quiet we shall get neither justice nor fair play for our people. As a result of the whole thing our Christians of Kastura seem to have picked up courage, and probably we shall lose only those that were already doglas (bastard Christians)." He ends by saying that all these days, from 4th till 12th July, he was staying at Nagar. "The villainy I have seen there! The first days I felt completely disheartened, enervated; but good God has well arranged everything, and the issue of the case has done me more pleasure than if we had gained it!"...

The promised 'details' arrived in a letter dated Kurdeg 20 July 1911 the Father thanks Fr. Waelkens for having sent to His Grace a copy of his letter of 2nd July (Kastura case). He adds: I am not astonished, now that I have seen how things are proceeding in Jashpurnagar, that Fr. Bressers' people do not dare go to court. I think anybody who reads and understands what I have still to relate would come to the same conclusion, namely, that it is useless for our Christians to hope for justice there. Not only this, but as I have been with them in the fight, I may say that more than once I have felt disgusted and enervated at the rascality of the police. If it had not been that our Lord was taking care of us, (and more than once I could see that He was directing circumstances), and that there was question of the souls of these poor people, I would have run away in disgust.

"However I wanted to follow the whole thing from close by. I had very little hope of obtaining justice, but at least this occasion would put in our hands well ascertained facts and clear proofs of the way in which our Christians were treated. I continue then to give you the facts. Once for all I may say that I relate only things of which I am certain. If I have any doubt about one point or other, I shall say it."
